Students are nominated by their home universities by submitting the [nomination form](#) to erasmus@vsfs.cz. The nominated students then apply online by filling out the application form (<https://www.vsfs.cz/en/?id=2084-application-form>) and uploading a CV, a cover letter, a photo, a proof of health insurance, a copy of passport/ID card and a Transcript of Records.

Language level: Students are expected to have at least a **B2 level English**. However, no language proficiency certificate is required. The sending institution is responsible for ensuring an appropriate language knowledge of their students.
